




SUGAR CHARACTERISTICS

The solid product obtained by crystallization from sucrose (C12H22O11) contained in the juices of sugar cane, sugar beets or other plant species through specific and specific industrial processes.

ODOR

The characteristic of sugar, without presenting a musty, fumigant or other strange odor.

FLAVOR

Characteristic sweet, without other strange flavors.

PHYSICAL ASPECT

Crystals.





SUGAR **PRODUCT**

STANDARD SUGAR

Solid product derived from sugar cane, consisting essentially of loose sucrose crystals, in a minimum concentration of 99.40% polarization. This type of sugar is obtained through a process similar to that used to produce raw sugar (muscovado), applying variants in the clarification and centrifugation stages, in order to obtain the quality of the desired product.

REFINED SUGAR

Solid product derived from sugar cane, consisting essentially of loose sucrose crystals, at a minimum concentration of 99.90% polarization. This type of sugar is sometimes obtained from raw (muscovado) or standard sugar through a refining process.
